Note that the two rings will run simultaneously. Advanced Standard 1 and Starters Standard 1 will both start at 5:15p.m. Advanced Gamblers 1 and Starters Gamblers 1 will also start at the same time to allow dogs to enter the standards and games at different levels.

## ***General Information - Notice to Participants***

For these Starter/Advanced trials you can move up from starters to advanced but not to masters since that is a different trial. . However, a title gained early at the trial does not preclude the dog from competing in the remaining events for qualifying scores, even if now below the dog's level. **Junior Handler** class is offered. Each handler must have a Junior identification number and the dog must have an AAC ID card.

Competitors, through the submission of their entry, acknowledge that they know the AAC rules and regulations. **All dogs must have an AAC identification number and enter it on the entry form.** NOTE: AAC regulations require the handler to obtain an ID card directly from the AAC. If you do not have an AAC ID card for your dog, please obtain the AAC Registration Form from the AAC website ( [http://www.aac.ca/en/forms/\\_pdf/AAC\\_DogIDCardEN.pdf](http://www.aac.ca/en/forms/_pdf/AAC_DogIDCardEN.pdf) ) and submit it directly to the AAC. A valid AAC card must be presented at the trial check-in for all dogs in any starters class events, and for all dogs running for the first time at More Dogz trials. You may also be requested to show your AAC Dog ID card at any time by the judge or the Clubs, so please be sure to have it with you.

There shall be no refunds for entries withdrawn after the closing date, or in the event a dog and/or handler are dismissed from competition, regardless of the reason for such dismissal, or in the event of inclement weather. Refunds will be issued for dogs that come into heat or are injured, providing the Trial Secretary receives a veterinarian's certificate within 48 hours of the start of the trial.

Come for all weather conditions and bring chairs. As there are no provisions for sun or rain, bring shade/rain gear and sun block. Water for the dogs will be available around the show area.

**Obstacles may include:** A-frame, Dog Walk, Teeter, Weave Poles, Table, Flexible Tunnels, Collapsible Tunnel, Tire Jump, Spread Jump, Double Bar Jumps, Single Bar Jumps, Broad Jump.

## ***Entrance Priority***

This is a limited entry trial, entrance is on a first come/first in basis. More Dogz members have priority entrance.

## ***Awards***

- Placement ribbons for 1<sup>st</sup> through 4<sup>th</sup> place for each division
- Qualifying ribbons for all AAC agility qualifiers
- Titling rosettes acknowledging dogs who achieve an AAC agility title
- Prizes for the best run in a competitive grouping, typically Regular and Specials/Veterans. More prize categories are added when numbers warrant it.

## ***Trial Notification***

You will be notified an acceptance or denial of the trial by the previous Thursday of the trial. If you have not been notified of either then please contact George by e-mail before the Monday of the trial. It is likely your entry was not received or been miss-filed and it will be possible you could still get into the trial. No corrections will be made after the Monday before the trial.

In consideration of the acceptance of this entry by AAC and **More Dogz** and the opportunity to have the Dog participate, compete in and/or be judged at this event or trial (the “Event”), I, the undersigned, agree as follows:

1. I certify that I am the actual owner of the Dog, or that I am the duly authorized agent of the actual owner of the Dog and that the Dog is not a hazard to persons, property or other dogs.
2. I agree that AAC or the Organizing Club for the Event may refuse my entry for any reason that it deems to be sufficient.
3. I understand and acknowledge that participation in the Event carries certain risks, including, but not limited to injuries (including serious injuries and death) to myself, the Dog, another dog under my control or persons attending as my guests (my “**Related Parties**”), damage to property and other losses. I waive any and all claims that I have or may have in the future against, and release from all liability and agree not to sue AAC, the Organizing Club or any of the directors, executives, committees, representatives, employees, volunteers or agents of either AAC or the Organizing Club (the “**Personnel**”) for any injury, death, property damage or other loss that I or my Related Parties sustain due to any cause whatsoever, including negligence, breach of contract, breach of duty, statutory or otherwise, or mistakes or errors of judgment of any kind.
4. I assume full responsibility for the conduct of myself and my Related Parties during the entirety of the Event. I agree to indemnify and save harmless AAC, the Organizing Club and the Personnel from and against any and all claims that may be made against them or costs, fees, expenses or liability (including, without limitation, lawyers’ fees on a solicitor and own client basis) incurred by AAC, the Organizing Club or the Personnel that may arise due to:
  - (1) any act or omission of myself, my Related Parties or any party for whom I am liable at law; or
  - (2) aggressive behaviour by the Dog or any other dog under my control.

I have read, and do understand the rules of competition and the additional rules (if any) appearing in the trial schedule for the Event, as well as the policies of AAC pertaining to discipline (collectively, the “**Rules**”). I agree to abide by the Rules and to conduct myself and the Dog in accordance with the Rules. I understand that myself and/or the Dog may be subject to disciplinary procedures or sanctions for breach of the Rules and agree to respect and be bound by any disciplinary decision made by AAC.

I understand that AAC and/or the Organizing Club may, in the course of administering the Event or conducting its activities generally, collect, use or disclose my personal information and that any personal information collected, used or disclosed by AAC and/or the Organizing Club will be treated in accordance with AAC policy and applicable privacy and personal information laws. I hereby consent to the collection, use and disclosure by AAC and/or the Organizing Club of my personal information.
